APPLICANT LIVE SCAN INSTRUCTIONS

The next step in the process regarding your CCW Permit Application is to conduct your background investigation. This will be accomplished at the Federal, State, and local levels. You are instructed to call and make an appointment at one of the following locations. (do not go to any other location) to be fingerprinted, by the Live Scan Method. You will be charged a \$10.00 fee at the time of your service, by the facility providing the service. You MUST have the Live Scan Request Form with you.
